Resilient Retreat is building an 18,000 square foot retreat center on 84 acres of preserved land, where survivors and first responders/helping professionals will be hosted for 3-5 day retreats, where they will have the opportunity to sample a wide range of evidence-based programs, to see what is most helpful and resonates most with the participants of the retreat. The retreat is expected to be fully operational in Spring 2022. The Retreat Center will also hold a variety of day and evening programming for survivors of trauma, first responders, teachers, medical professionals, mental health professionals, advocates, and social workers so that we can meet the needs of the local community.

possible under circumstances not producing a conflict of interest, the governing board or committee shall determine by a majority vote of the disinterested directors whether the transaction or arrangement is in the corporation's best interest, for its own benefit, and whether it is fair and reasonable. In conformity with the above determination it shall make its decision as to whether to enter into the transaction or arrangement.

Violations of the conflict of interest policy. If the governing board or committee has reasonable cause to believe an interested person has failed to disclose actual or possible conflicts of interest, the board or committee shall inform thee interested of the basis for such belief and afford the interested person an opportunity to explain the alleged failure to disclose. If, after hearing the interested person's response and after making further investigation as warranted by the circumstances, the governing board or committee determines the interested person has failed to disclose an actual or possible conflict of interest, the governing board or committee shall take appropriate disciplinary and corrective action.
